Hurricane Matthew Recovery Project

Hyde County Drainage District #7 will be soliciting bids for the Hurricane Matthew Recovery Project on the property located on and within the Districts Dike and Canal System around Fairfield, NC. The Hurricane Matthew Recovery Project is a levee/dike stabilization and debris removal project with the continued protection of the village of Fairfield and the surrounding area as the primary goal.

This project is being supported with Federal Emergency Management Agency, Disaster Recovery grant funding. Therefore, certain restrictions and other federal requirements attach to this opportunity.

Separate sealed bids for the Hurricane Matthew Recovery Project will be received by Hyde County Drainage District #7 at The Hyde County Government Center, 30 Oyster Creek Rd., Swan Quarter, NC 27885 until May 17th, 2019, and then at said office publicly opened and read aloud. Any person with disability requiring special accommodations must contact Daniel Brinn no later than 7 days prior to the bid opening.

A MANDATORY Pre-bid Meeting will be held Friday, May 3rd, 2019 at 10am, at the Hyde County Government Center, 30 Oyster Creek Rd Swan Quarter, NC 27885. All bidders are required to attend the Pre-Bid Meeting and sign the attendance sheet at the meeting. Bids received from bidders who have not attended the Pre-Bid Meeting and signed the attendance sheet at the meeting will be considered nonresponsive.

in any contract entered into pursuant to this advertisement bidders will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex, religion, age, disability, sexual orientation, gender identity or national origin, in consideration for an award. Hyde County Drainage District #7 is an Equal Opportunity Employer. We encourage all small and minority owned firms and women's business enterprises to participate. Bidders may withdraw its bid anytime prior to the date of the opening of the bids. No bidder may withdraw its bid after 5 days from after the actual date of the opening thereof, unless a contract between the bidder and Hyde County Drainage District #7 has already been executed by the bidder.

PLEASE NOTE: Official planholders list will be only the list maintained by Daniel Brinn. It is the sole responsibility of all planholders, whether they have received digital downloads or paper copies of the plans and specifications, to periodically to check for Addenda which may have been posted on www.hydecountync.gov

Bidders must agree to comply with Prevailing Wage Rate provisions per existing federal requirements. Contractors must not appear on Sam.gov disbarment list.

A detailed listing of all subcontractors shall be provided by the Bidder. In accordance with the Contract Documents, documentation that the prospective General Contractor and its subcontractors meet minimum qualifications shall be provided and submitted. Subcontractors must be procured using applicable 44 CFR guidelines and documentation must be provided to Hyde County Drainage District #7.

The successful bidder will have to sign an agreement that they are enrolled and participating in a Federal Work Authorization Program ("FWAP") that ensures that all of its employees or agents or subcontractors have the legal right to work in the United States, including alien workers as set out in 8 U.S.C. 1324a(h)(3) and compliance with North Carolina General Statute §143-133.3, that it will maintain this compliance for the entire duration of its contract with the Hyde County Drainage District #7, and will provide an Affidavit of Compliance to the Hyde County Drainage District #7 stating the same.

A bid bond or certified check for five percent (5%) of the total bid amount must accompany each bid. The successful bidder will be required to furnish a performance bond in the amount of its bid and shall, before entering on the work of said contract, be licensed as a contractor by the State of North Carolina.

Hyde County Drainage District #7 reserves the right to waive any informalities or to reject any or all bids.
